The 6th Annual Parents' Survey was completed by 159 parents and carers in 2013. The overall results continue to improve with 10 record high satisfaction rates from a total of 19 questions. The response rate is similar to 2012 although we are grateful that many more parents completed the Ofsted Parent View questionnaire which was running in parallel with this survey. This survey provides us lots of detailed feedback which is very valuable.

We were particularly pleased to have the endorsement of 99% of parents who believe that the College is well led and managed. The area of concern continues to be setting and marking of home learning although we are continuing to improve.

Where there are common issues raised and for those questions which received the poorest satisfaction rates we have provided feedback on what actions we are taking to address your concerns.

Finally, we would like to thank all those parents who have taken the time to complete the survey and to tell us where we are doing well and how you think we could do better.

Use our on-going staff development programme to ensure all teachers can improve their practice and set a target for this in the College Improvement Plan. |
| | There are teaching staff that are not as good, in particular offering help to students when they notice they struggle in a topic. | Use student voice activities to provide more opportunities for students to request individual help. Ensure curriculum leaders provide a range of curriculum resources to help students and parents consolidate learning. Follow up quickly on any issues raised via the Parental Concerns system. |

| activities, healthy choices of food and good personal and social education. | The amount and quality of work set as home learning is variable with some parents stating that too much is set and others that too little is set. | Put in place a regular book scrutiny programme which will quickly highlight any areas of concern regarding the frequency and/or suitability of home learning tasks and activities. Ensure our policy is more visible to parents through termly updates/ reminders via reports, the newsletter and discussions with tutors at Parents' Evenings. |
| Appropriate home learning is regularly set. | Not all home learning tasks appear to be marked and this is demotivating for students. | Introduce a new marking policy to promote consistency in the marking of work and to improve the quality of feedback. Ensure that 'deep marking' will take place at regular intervals with the frequency depending on the subject and the type of work set. This marking will include WWW (what went well) and EBI (even better if). Students will then be given the opportunity in lessons to address the feedback using INT (I need to). Students will update their work using purple pen in order that corrections/refinements etc. are easily seen. |
